Mare and stallion inspections 2022 - after months of planning, our inspection programme is now under way.

#### Stallion inspections: 1 and 2 September 2022

The 2022 stallion inspections will be held on 1 and 2 September at Warwickshire College, Moreton Morrell, near Warwick.

As in 2021, we have had a great deal of interest in our stallion inspections, with 14 applicants, although we are still in the process of reviewing x-rays, so we may not have quite this number forward on the day. The applications for stallion classification closed on 15 June 2022. Most of the x-rays have now either been read or are lodged with the radiograph panel.

When the panel has reported on all the x-rays, the timetable for inspection will be published on our website. Although we have two days booked, we will certainly finish at the very latest by 12 noon on 2 September, and may even be able to finish in one day. Please keep an eye on the website and Facebook for updates on this.

Spectators are welcome at this event, but please let us know at <a href="mailto:inspections@idhsgb.org.uk">inspections@idhsgb.org.uk</a> that you wish to attend. This is because we have to provide Warwickshire College with approximate numbers of people likely to be on site. If you intend to come to learn more about the inspections with a view to bringing a stallion forward next year, please make yourself known to us so that we can make someone available to answer any questions you may have.

#### Stallion inspections 2023

We are well aware that there are strongly-held views on both sides (Easter vs. September) regarding the timing of the stallion inspections going forward. We appreciate your messages and emails putting forward your views, but we want to make sure that all stakeholders have an opportunity to comment, and that people's views are professionally evaluated so that any survey is both reliable and representative. The Council are meeting on July 7 and at that meeting, we will decide best how to proceed. Please be assured that we will manage this process fairly and transparently.

# Mare inspections 2022

Results from the first two inspections (full results will be posted on our website when available):

Thirteen mares came forward, one of which is awaiting the outcome of a veterinary referral. Of the 12 other mares, nine met the veterinary and inspection requirements for Class 1. Three mares met the veterinary requirements and did not meet all of the inspection requirements, so they have been classified as Class 2. Both Class 1 and Class 2 mares are part of the breeding herd, and their progeny by inspected Irish Draught stallions are eligible for inspection. All these mares and their progeny are now eligible to be shown in hand in affiliated Irish Draught classes.

One Hornby Premium was awarded, the first one of the year, to Castlerise Sparkling Ginger owned by Mr and Mrs Comb.

#### Applications for the Hornby-Lonsdale Trust Hornby Premium inspections (closing date 15 July 2022)

Inspections for Hornby Premiums can take place at all mare inspection venues for grading. They can also take place at regional shows, provided that the show secretary has given permission and that if the judges are needed to inspect, it does not interfere with their judging commitments. Please apply straight away if you would like your mare to be inspected for a possible Hornby Premium. There are specific requirements for eligibility, which are listed on the application form on our website.

#### Irish Draught Studbook Inspection Amnesty

The Irish Draught Studbook inspection amnesty permitted animals that met the pedigree requirements for the Irish Draught Studbook, but which had one or more uninspected parents, to come forward for inspection between the years 2017-2021.

The amnesty ended in December 2021. There are no immediate plans to extend it. This means that animals affected by the Amnesty cannot currently come forward for inspection. We understand that the Task Force is to be reconvened in time to reach a decision for 2023 inspections, but at the moment, no one can guarantee this.

If you are buying an Irish Draught foal and you wish to breed purebred Irish Draughts from it in future, or show it, please make sure that the inspection status of its parents meets your future needs. If you are concerned about the status of a young horse in terms of inspection eligibility, please email the inspection management team on inspections@idhsgb.org.uk

# Inspection fees

**Stallion inspection fees** were raised by £10 this year, but will need to increase again next year because veterinary charges have gone up.

We have kept our **mare inspection fees** the same for this year, but due to the unforeseen and very rapidly rising costs of fuel (and the knock-on effect on veterinary services), they will be increased for 2023.

### Updating Horse Sport Ireland passports for horses living in Great Britain

Due to Brexit, the European (EU) Breeding Regulation no longer applies in the United Kingdom. The Department of Environment, Food and Rural Affairs (Defra) has drawn up its own rules for passport-issuing organisations in England, Wales and Scotland. Equines in Northern Ireland are not affected by this change.

Historically, regulated changes to passports for Irish-bred horses, such as upgrading HSI foal identity documents to full pedigree passports, naming and transfers of ownership, always had to be completed by Horse Sport Ireland (HSI). The passport would then be sent to the IDHS (GB) passport administrators for overstamping. This is a legal requirement, so that this information can be uploaded to the Central Equine Database. Up until recently, owners of Irish-bred horses had to send the passport to Horse Sport Ireland first, and then to us.

As a result of Brexit, no passport-issuing organisation in Great Britain is permitted to process any passports for animals living outside Great Britain. This is reciprocal; i.e. Horse Sport Ireland is not allowed to process passports for animals living outside the island of Ireland.

On 10 June, we received definitive guidance on the procedures for updating Horse Sport Ireland passports if the horses are living in the UK. We can now offer the following services for those horses:

- Naming, re-naming (Irish passports only), changes of ownership, addition of microchip numbers and other minor changes.
- Overstamping: If you have imported an Irish Draught or Irish Draught Sport Horse from the Republic of Ireland (or any other country outside the UK), you MUST ensure that the passport is over-stamped by a Passport Issuing Organisation (PIO) in the UK, so that the animal's record can be included on the Central Equine Database.
- Duplicate passports where the original is lost, stolen or damaged
- Upgrading Irish foal papers (identity documents) to a full passport once DNA parentage testing has been confirmed. If you want an Irish full passport for your Irish-bred foal or young horse, please arrange to have this work done before you import the animal. Once it is in Great Britain, it must have an IDHS (GB) full passport.

The fee structure will be kept under review, but is in line with the fees for passport services for British-bred horses. Thank you for your patience while we were waiting for guidance from Defra and DAFM.
