## COMBINED FORM FOR NAMING, TRANSFER OF OWNERSHIP AND OVERSTAMPING

**All applicants must complete sections 1 and 5, please, plus any other applicable sections.**

Owners of horses which have Horse Sport Ireland passports but which are resident in the UK may, if they wish, continue to apply to Horse Sport Ireland to update the name and transfers of ownership, but our passport administration office can also carry out these changes.

**NAMING:** This form can be used to assign a name or change a name for an animal registered in the Irish Horse Register, i.e. a horse with a Horse Sport Ireland passport, so long as the horse is normally resident in the United Kingdom.

This form can also be used to record a new name for a previously unnamed animal in the Irish Draught Horse Society (GB) breed, sport horse or utility (identity only) registers. IDHS (GB)-registered horses cannot be re-named. **Please see Section 2 for naming.**

**CHANGE OF OWNERSHIP:** You may use this form to apply to record a change of ownership for Irish Draughts, ID Sport Horses and Utility passport horses registered with IDHS (GB). **Please see Section 3 for changes of ownership.**

**OVERSTAMPING:** This form can also be used to overstamp any horse registered with another passport-issuing organisation, here or overseas, with the IDHS (GB). **Please see Section 4 for over stamping.**
