## **PASSPORT OVERSTAMPING**

The IDHS (GB) Administration Office can carry out overstamping for Irish-bred animals which are now resident in the UK.

There is a separate form on our website at <a href="www.idhsgb.org.uk">www.idhsgb.org.uk</a> for transfers of ownership for horses registered with us. If paying for a transfer of ownership along with a request for overstamping, you are entitled to a discount.

If you wish to name or re-name a horse which has a Horse Sport Ireland passport, please send the passport to Horse Sport Ireland in good time to receive it back for any planned events. The IDHS (GB) is unable to name horses which are registered with other passport-issuing organisations. Please have your horse named with HSI before asking us to overstamp it.
