PASSPORT UPDATE FORM: TRANSFER OF OWNERSHIP

Please read carefully and follow the instructions below. If any requested information is missing, applications may be returned to the sender for correction.

The IDHS (GB) primarily carries out changes of ownership for horses registered with our Society. Under a DAFM and Defra joint protocol, we can also transfer ownership for Horse Sport Ireland (HSI) passports, but ONLY if the horse is resident in the UK.

If you also wish to overstamp the horse's passport at the same time as transferring ownership, you can pay for both services in one go. There is a discount available. Please see the list of passport update fees below. You can pay through our website at www.idhsgb.org.uk (Miscellaneous Payments). There is a separate form on the website for over stamping. We cannot name horses with passports issued by other agencies. They must be returned to the organisation which issued them.

To transfer ownership of a horse, either the vendor or the purchaser can apply. Please enclose the passport with the completed form. The Society reserves the right to verify any information on this form.

Vendors: please complete Sections 1, 2 and 3.

If the vendor has not carried out the transfer, the purchaser MUST complete Sections 1, 4, 5 and 6. The purchaser must also send in **proof of ownership** (a bill of sale or receipt, etc).

If the horse is jointly owned, we require all owners' signatures to be on this form. Young people under 18 can be named as an owner, but this form must be counter-signed by someone who has parental responsibility for that young person.
